### **GENERAL INFORMATION:**

**COVID RESTRICTIONS:** We will be running on a block schedule format. This schedule will come out no later than 6/12 & be based on the amount of entries so that it is in the best interest for the competitors. Every athlete will be allowed to have 2 spectators. No changing tents will be allowed. One costume will be able to be worn for all your solo events (besides those entered in the regional pageant) and judges will be notified to judge accordingly. Teams, Show Twirls & Rhythmics will be able to change costumes during their block in the restrooms and/or locker rooms. Not sure if concessions will be offered. Every athlete will need to provide his or her own water bottle. Health Screening will be required when entering the building. Masks will be worn at all times. More details will come out with schedule on 6/12.

Schedule Information: The contest will be held on Saturday & Sunday allowing sanitation time between “blocks”. There will be a clinic offered during the weekend as well. We will have an awards ceremony for the Regional Pageant & Regional Events. All open awards will be able to be picked up with score sheets at a designated time. Practice gym will be available.

1. Soft rubber soles on gym floor.
2. Directors send in team entries & group roster.
3. **REGIONAL CONTEST DEADLINE: May 29<sup>th</sup>, 2021.** NO LATE STATE ENTRIES WILL BE ACCEPTED. NOTE: REGIONAL team events are on Sunday. Sorry, No Refunds.
4. **OPEN CONTEST DEADLINE: June 5<sup>th</sup>, 2021.** If entry for open events is postmarked after 5/29/21, include late entry fee of \$5.00 per event entered. Late entries must be received by June 5<sup>th</sup>, 2021. Sorry, No Refunds.
5. In the spirit of safety, courtesy, and fairness to all, NBTA encourages voluntary cooperation limiting video taping to: (A) Parent videotaping own child (B) Teacher videotaping own student (C) Group Director/appointed person videotaping own group or corps (D) Safety first applies, no tripods, extension cords or artificial lights. Common sense prevails. No videotaping will be permitted in immediate area behind or around judges or official contest tables.
6. No flash photography will be allowed in the gym areas.
7. **Admission for contest:** In order to eliminate lines to enter the building, there is a processing fee of \$15.00 that has to be included with each entry. This fee applies to individual team members as well. If there is more than one child in a family competing, or if your child is in teams and solos, then only one processing fee will be paid. This is a flat fee that includes the Regional & Open Contest.
