#### **GENERAL INFORMATION:**

1) Programs will be sent out via email prior to the competition.

2) Everyone who competes must have USTA membership or Non-Member fee in his/her own name.

3) Only residents of the Sotheast Region may enter the Adv. Regional Individual competition. In Duets/Pairs,

at least one (1) group member must reside in the Southeast Region.

4) Current USTA rules will be in effect. Any questions pertaining to rules, time limits, etc. can be

clarified through the USTA handbook, USTA website or USTA Headquarters.

5) Age on the entry is the athlete's age as of August 31, 2024.

6) The competition will be run on the set system.

7) Individuals and Groups must compete at their eligibility level as of April 1, 2024

8) DEADLINE is May 15, 2024. Payment is due upon submission of online entry.

9) The USTA Southeast Regional Baton Council reserves the right to divide or combine age groups as necessary.

10) NO REFUNDS will given for any reason, other than if contest is cancelled.

11) Novice athletes are those who have won less than 3 competitive first place in that event. Beginner athletes have won less than 5 competitive first places in that event. Intermediate athletes have won less than 10 competitive first placs in that event. Advanced athletes have won 10 or more competitive first places.

12) Time limit for Beg & Int Duet is 1.29 minutes. Adv. Duet 1:44 min. Age division for Duets are as stated in the USTA Rulebook.

13) Athletes will know their score immediately upon completion of their routines; judges will score on the Olympic System. No score sheets will be given. Basic, Military, and Presentation Events will not flash scores.

14) The "Regional" awards presentation for individual events will be at the end of the Regional day on Sunday.15) Beginner team is one with less than 5 competitive first place awards (having competed against another group.) Intermediate team is one that has won less than 10 competitive first places. Advanced team is one that has won 10 or more competitive first.

16) Dance Twirl Teams and Twirl Teams may enter ONE level unless a 50% membership change occurs, per USTA r All teams may additionally enter the Open Teams Critique events.

Twirl Teams and Dance Twirl Teams levels with Content Restrictions are as follows: Novice, A, AA, AAA and Elite (no content restrictions).

#### Twirl Teams and Dance Twirl Teams will be recorded in the event Content Restrictions need reviewed.

17) Group musice must be uploaded into the Jotform at time of team entry with proper formatting/naming. No CDs or cell phones allowed.

18) The process of establishing a team / trios or corps age division is by averaging the ages of the members. Add all the ages together, then divide by the number in the group. Each group will have the option of competing in an older division than the average age if there is at least one member whose age is within that higher age division. When the aberage age has a decimal digit, drop the decimal and use only the number as the average age. Primary 0-9.99, Juvenile 10-13.99, Junior 14-17.99, Senior 18+ Tiny Tot Dance Twirl Team - ALL members must be 7 years of age or younger.

19) Spectator Admission is free.

20) Athletes may only enter "one level up" from their current level in a particular event, ecluding critiques. Example: Beginner Solo athlete may enter Beginner and Intermediate Solo.

21) Please refer to the current USTA Rule book for all procedures.

22) No flash photography is allowed at any USTA contest for the safety of the athletes.

23) Contest Directors, USTA Southeast Regional Twirling Council, or Facility will not be responsible for accidents or lost / stolen items.
