INFORMATION AND INSTRUCTIONS FOR INDIVIDUALS AND GROUPS

Ages: Athletes must enter the NER Championships at the age they will be on August 31, 2026

Competition Level: Athletes and groups will compete at their level of competition as of the NER deadline date, April 1, 2026. Effective September 1, 2019: Athletes may only enter 'one level up' from their current level in a particular event. For example, a Beginner athlete may enter Intermediate but not Advanced since that would be considered 'two levels up.'

USTA Membership: All participants must hold some form of USTA membership; **USTA Intro Membership** fee will **NOT** satisfy the membership requirement of the NER Championship. Visit www.ustwirling.justgo.com for online membership application.

Deadline/Method of Payment: USPO postmark by midnight APRIL 1, 2026. No metered mail. No phone, hand delivered, or mail that requires signatures will be accepted. **Money order/bank certified checks ONLY – payable to: North East Regional Council**

Registration Fee (Individuals & Duet/Pair Mbr) - \$40: Mandatory for all individual/duet/pair participants (both duet/pair partners pay). This fee helps defray costs such as the use of the facility, surcharges, and awards, as well as judges' fees, airfare, food and lodging.

Music: Music for Teams, Groups, Trios, Corps and Collegiate: must be emailed by May 11, 2026, to NERtwirlingmusic@gmail.com. **Music for Solo, 2-Baton, 3-Baton and Duet:** Adv Solo/Duet will be performed to the IBTF IC Solo music. Nov/Beg/Int Solo, Beg/Int Duet, & all 2 & 3 Baton (Beg/Int/Adv) will be performed to the IBTF IC multiple baton music. **Music for Artistic Twirl & Artistic Pairs:** All Artistic Twirl/Artistic Pairs will be performed to the IBTF Artistic Twirl. Music is available for free download on www.ustwirling.justgo.com.

Finals for Individual Events 2026 NER will be following USTA National format for finals.

Private Lessons: PRIVATE LESSONS ARE NOT ALLOWED ANYWHERE ON CAMPUS!

Parent/Guardian Responsibilities: Before signing the waivers at the bottom of individual and group entry forms, parents/guardians agree to read the Parent/Guardian Responsibilities contained in the current USTA Rule Book.

Team/Group Entry Form:

1. This form contains two pages. The group waiver must be signed.
2. **All entries must be accompanied by an attached roster.** Please type or print clearly. All group entries must include a roster of names, ages (as of 8-31-26), birth dates, USTA #'s, and average age for each group. Include the music name for each entry on your roster list.
3. To avoid personnel conflicts, all members of more than one team/corps/organization must be designated on a separate list and attached to the roster. List the name of the other groups; specify category, level and age division.
4. **Fee columns** include USTA surcharge. **Registration** is \$10 per athlete in lieu of admission fee. **Organization fee** \$45, pay once per organization. **Please do not staple payment to entry form.**

Team Ages: Team average age – **Tiny Tots all members** must be 7 or under; **Primary** 9.99 & under; **Juvenile** 10-13.99; **Junior** 14-17.99; **Senior** 18 & over. Dance Twirl Teams who enter Novice, A and/or AA level of competition (if eligible), may not enter the AAA or Elite level of the competition. If they enter more than one level of competition (for instance A and AA), then they must have at least a 50% membership change between the two teams. Twirling Teams may only compete in one age category and level unless there is a 50% or more change in team membership. Trios may only compete in one age category per event unless there is a 25% or more change in team personnel. (Rulebook page 34) Trio (Primary, Juvenile, Junior and Senior) consists of 3 members. Small teams consist of 4-8 members. Large teams consist of 9+ members. Artistic Group and all Corps are 10+ members.

Classification for Artistic Groups, Show Teams: One division is offered.

Classification for Parade Corps and Entertainment Corps: Youth, Junior, Senior

Classification for Dance Twirl and Twirl Teams: See USTA Rule Book

Team/Group Time Limits: **Twirling Teams** 2:00-3:30 min. with 10 sec. leeway; **Dance Twirl Teams** 2:00-3:00 min. with 10 sec. leeway. **Trios:** 2:00-3:00 min. with 10 sec. leeway. **Parade Corps** 2:00-4:00 min. with 10 sec. leeway, forward progression movement 1:30 min., 10+ members. **Entertainment Corps** 3:00-5:00 min. with 10 sec. **Show Teams** 2:00-3:00 min. with 10 sec leeway. **Artistic Groups** 3:00-3:30 min. with 10 sec leeway - one level, 10+ members. Reference the USTA Rule Book.

Team Restriction: See USTA Rule Book

Order of Performance for Team/Trio/Corps/Group Day: Events will be scheduled in the order that prevents as many personnel conflicts as possible. Retreat and awards will occur following the final set. **Lineups** will be sent to Directors approximately 2 weeks prior to contest.
